- 2) **H.Con.Res. 147** - Recognizing 200 years of research, service to the people of the United States, and stewardship of the marine environment by the National Oceanic and Atmospheric Administration and its predecessor agencies, and for other purposes (*Sponsored by Rep. - 3) **H.R. 3998** - To authorize the Secretary of the Interior to conduct special resources studies of certain lands and structures to determine the appropriate means for preservation, use, and management of the resources associated with such lands and structures (*Sponsored by Rep. - 6) **H.R. 1662** - To amend the Reclamation Safety of Dams Act of 1978 to authorize improvements for the security of dams and other facilities (*Sponsored by Rep. Napolitano / Natural Resources Committee*)
