- 2) **H.Res. 657** - Expressing heartfelt sympathy for the victims of the devastating thunderstorms that caused severe flooding during August 2007 in the States of Illinois, Iowa, Minnesota, Ohio, and Wisconsin, and for other purposes

- 3) **H.R. 3068** - Federal Protective Service Guard Contracting Reform Act of 2007
